

# **NSW Central West Division of General Practice DonateLife Week 2012 Hayman Island Getaway Competition Terms & Conditions**

## **NSW Central West Division of General Practice Ltd 'DonateLife Week 2012 – Hayman Island Getaway' promotion**

- The Promoter is NSW Central West Division of General Practice Ltd (CWDGP) of 265 Durham Street, Bathurst, NSW, 2795.
- Entry into promotion deems acceptance of these Terms and Conditions.

### **1. YOUR ENTRY**

- Competition entry commences 18 February 2012 8am (AEST), through to 27 February 2012 8am (AEST). The winner will be announced 2 March 2012 12pm (AEST) via the CWDGP website.
- To enter the promotion, entrants must complete a DonateLife Week 2012 'Ask and know your loved ones wishes' postcard at information stalls throughout the Central West during DonateLife Week 2012 (19-26 February 2012), submit the completed postcard for posting and tear off entry-form into the entry barrel.
- To adhere to competition guidelines, the submitted entry must adequately provide the prompted information on the tear off entry form (first name, last name, address and email).
- CWDGP takes no responsibility for lost, late, incomplete, misdirected, damaged or destroyed entries.

### **2. ELIGIBILITY**

- Employees of The Promoter (CWDGP), project contractors and their immediate families are ineligible to enter.
